Commencement of Academic Session 2026–27 & Registration of Continuing Students

Dear Students,

The University is pleased to announce that the **Academic Session 2026–27 will commence on 20 July 2026 (Monday)**. All continuing students are required to complete **registration, fee payment, course registration, and hostel formalities** on **17–20 July 2026**. Hostel reporting will take place between **17–20 July 2026**.

Registration & Fee Payment

- Registration is valid only after depositing **minimum 25% of the annual fee (including hostel charges, if applicable)** by **20 July 2026**.
- **Fee Schedule:**
 - First Installment (60%): by **30 October 2026**
 - Second Installment (40%): by **31 March 2027**
 - Late fee: ₹50 per day after due dates and maximum upto balance amount pending.
- **Payment Mode:** Online only (UPI, NEFT, RTGS, IMPS, Net Banking, University Fee Portal).
 - Bank: ICICI Bank, Modi Nagar
 - A/c No.: 125701002314 | IFSC: ICIC0001257
- Students must upload proof of payment on the University ERP/Student Portal.

Education Loan & Scholarships

- Students paying via **Education Loan** must obtain a Fee Demand Letter from the Registrar's Office and ensure loan credit preferably before **31 August 2026**.
- Scholarship applicants (Central/State Govt., NSP, AICTE, UGC, etc.) must complete formalities within prescribed timelines. Fee not covered under scholarships must be deposited as per rules.

Attendance Requirement

- A minimum of **75% attendance** in theory, practical, workshop, project, and laboratory components is mandatory.
- Students below this threshold will not be permitted to appear in internal assessments, mid-semester, or end-semester examinations.
- Shortage of attendance may be considered for condonation by the competent committee.

Anti-Ragging Compliance

- The University follows a **Zero Tolerance Policy** towards ragging.
- All students must submit the online undertaking via www.antiragging.in and forward confirmation to Nodal officer at antiragging@dknmuncr.edu.in before registration.

- Any violation will invite strict disciplinary and legal action.
